THIS IS TO CERTIFY:

First: That we, the subscribers

all being of legal age, do under and by virtue of the general laws of the State of Maryland, authorizing the formation of corporations, associate ourselves with the intention of forming a corporation.

Second: The name of the corporation hereinafter referred as the "corporation") is The Berwyn Rod and Gun Club, Incorporated.

Third: The purpose for which the corporation is formed and the business or objects to be carried on and to be protected by it as follows: To advance sportsmanship among it's members, enlarge and increase the opportunity for the enjoyment by it's members of out-of-door recreation, to promote trap, skeet and other forms of shooting to instruct in the use of fire arms, and to provide and arrange for the economical use of accommodations for the pleasure and comfort of it's members their families and friends and to further conservation of fish, game and forests in the State of Maryland.

Fourth: The post office address of the place at which the principal office of the corporation in this state will be located is at Berwyn, Prince Georges County, Maryland. The resident agent of the corporation is Joseph R. Berdes, whose post office address is Berwyn, Prince Georges County, Maryland. Said resident agent is a citizen of the State of Maryland and actually resides therein.

Fifth: All of the members of the said corporation shall constitute it's governing board.

Sixth: The corporation hereby formed is a voluntary organization of individuals having no capital stock and created solely for the pursuit and attainment of the purposes herein before mentioned and not with view of any pecuniary.

gain from profit to members, and whatever property-real, personal or mixed- that may be acquired by it or whatever income may accrue to the corporation from any source shall be held and utilized only for the prosecution of the objects and purposes aforesaid.

Seventh: The membership of the corporation shall be all persons who are now members of the Berwyn Rod and Gun Club. Members may be chosen and elected to or dropped from the roll of said corporation from time to time as may be prescribed or authorized by the By-laws.

Eighth: The corporation powers and duties in the entire management and direction of the corporation shall be vested in its members. The officers shall have such powers and duties as shall be expressly vested in them by the general laws of the State of Maryland and the By-laws of the corporation or the affirmative action from time to time of the members of the corporation.

Ninth: Rudy Boyer, Theodore Richards, Silas Sines, S. F. Richards and Joseph Bordas shall manage the affairs of the corporation until the first annual meeting, or, until their successors are duly chosen and qualified.

Tenth: The duration of the corporation shall be perpetual.
